MEMBERSHIP FORM - DUES STATEMENT

Delta Sailing Association is Memphis' one-design sailing club. DSA is home to Lightning Fleet #274, a large Hobie & catamaran fleet, and a number of other small boat classes. All classes of boats are welcome. Membership includes boat storage. DSA leases the yard at Hernando Point on Arkabutla Lake from the Army Corp of Engineers. DSA runs on volunteer help from its members.

By action of the members and Board of Governors at the Annual Meeting Nov. 25, 2003, all members enjoy similar rights and responsibilities and shall pay one basic annual fee with a surcharge for each boat beyond the first one. There is a surcharge for large boats.

Add \$90 Surcharge for Boats
over **20' long OR 1,000 lb** weight. (Total fee) ----- **\$315.00**

(DEDUCT \$25.00 FROM ABOVE RATES FOR DUES PAID BEFORE MARCH 31, 2020)
DUES ARE ON CALENDAR YEAR BASIS AND ARE NOT PRORATED.

EFFECTIVE IN 2012 DSA ADOPTED A "DELINQUENT PROPERTY POLICY."
BASED ON MISSISSIPPI LAW, THIS POLICY PROVIDES THAT YOUR BOAT
MAY ULTIMATELY BE SOLD TO SATISFY A LIEN IF YOU ARE DELINQUENT IN
PAYING DUES.

DUES FOR THE YEAR ARE DUE WHEN YOU PUT YOUR BOAT ON THE LOT AND WILL BE
CONSIDERED DELINQUENT BY JUNE 1, 2020!
PAYMENT OF DUES INDICATES AGREEMENT WITH DSA REGULATIONS AND A CONTINUOUS
CONTRACTUAL RELATIONSHIP UNTIL THE BOAT IS REMOVED.
